If we were connected to a sewer, our backwash would be sent directly to a sewer connection. Reviewed the cost to provide GIS Mapping of all the hydrants, valves, shutoff and mains for the District.

Update was given on the Collaborative Alliance Intergovernmental Agreement. Everything is ready to go.

Waiting on the results of the Health Physicist site visit and recommendations for IEPA/IEMA licensing. Cross Control Connection project is continuing. All lightning damage has been repaired. We are still working through programming issues with the various vendors. Plant will be run manually until such a time as we have a better comfort level with running the plant on auto. Working on the Consumer Confidence Report with the District Engineer.

A new Will County Board member from our District has been appointed. The Grundy County Administrator, Doug Pryer, has resigned. Followed up with Will County Landuse concerning a meeting over Will County potable water needs in the future.
